3.0 General

NiNAS makes use of several committees to carry-out its functions in line with international requirements for accrediting bodies. These committees are described in the Quality Manual and each has Terms of Reference in the NiNAS Management System. From time-to-time sub-committees may be formed to conduct specific and short-term tasks.

3.1 COMMITTEES

NiNAS Committees are:

The **Board of Directors**: Its function is to oversee the DG/CEO, finances, business strategy implementation and legal compliance of NiNAS.

The Accreditation Advisory Committee (AAC): which has the function of ensuring the impartial and objective operations of NiNAS as required by the international standard ISO/IEC 17011. It also has a role in the accreditation decision making. The AAC reports to the NiNAS DG/CEO.

The **Technical Committee:** is generally formed for all the accreditation schemes and provide a depth of technical expertise to address issues that arise in the application of standards related to accreditation and conformity assessment.
